CONDITIONS OF ENROLLMENT

The college reserves the right to cancel a course if enrollment is insufficient to cover the expenses of the course. If this happens, you will receive a full refund of tuition and fees you paid for the course.

AUDITING is possible in only a few lecture courses and requires prior written permission of the Registrar and the instructor. You will be charged 50% of the full tuition rate. This discount does not apply to any fees.

REFUNDS: If you withdraw from a course, tuition will be refunded according to a daily pro-rata schedule. The amount of refund is based on the date the official ADD/DROP form is received in the Registrar's Office.

TUITION WAIVERS: Any student aged 65 years or older may audit one VSC course per enrollment period without tuition charge. Additional courses may be taken without limitation, up to an including completion of a certificate or undergraduate degree, at the rate of 50% of the charged tuition. To be eligible, such persons may not take the place of full tuition paying students in courses with enrollment limits. Course specific fees, including registration fees, shall be the responsibility of the student. All other student fees are waived.
